




Federalism and the FDA



Jensen Farms

- Recall:
 - Listeria outbreak associated with cantaloupes
 - 33 deaths and 143 hospitalizations
- Criminal charges against the brothers who owned and operated the company
- A pure *Park* case?



Peanut Corporation of America

- Recall:
 - Salmonella outbreak associated with peanut products
 - Nine deaths and an estimated 22,000 illnesses
- Longest prison sentences ever for individuals involved in a foodborne illness outbreak
- Focus on "garden variety" fraud



Quality Egg

- Recall:
 - Salmonella outbreak associated with eggs
 - Over 1,900 reported illnesses
- Prison sentences for strict liability crimes





Trends?

- "Bread and butter" cases
- FDA's stated preference
- Scientific advances
- Changes in eating patterns
- High profile recalls/investigations
 - Will there be prosecutions?





A Telling Comparison

- Roos Foods (2016)
 - Listeria outbreak associated with cheese
 - One death and eight illnesses (per CDC)
 - Roof leaks, rust, product residue
 - Criminal charges against company
 - Civil injunction
- Vulto Creamery (2018)
 - Listeria outbreak associated with cheese
 - Two deaths and eight illnesses (per CDC)
 - Company testing continually found listeria, but failed to eradicate it
 - No criminal charges
 - Civil injunction




What Does ORA Do?

- Consumer Safety Officers (i.e. Investigators, Compliance Officers)
 - Inspections/Investigations

- Lab Analysts
 - Sample Analyses

FSMA Implementation





Food Safety Modernization Act (FSMA) mandates building the National Integrated Food Safety System (IFSS)

- IFSS- Interagency Partnership
 - Partnership for Food Protection (PFP) promotes the development and advancement of the National IFSS.



- FY 17/18 130 State Contracts = 25.3M
- FY 17/18 290 Cooperative Agreements & Grants= 85.5M
 - Human Food Preventive Controls
 - Animal Food Preventive Controls
 - Produce Safety Rule



- Regular and frequent work planning sessions
 - Improve information sharing
 - Reduction in duplication of inspections
 - Cost savings
 - Efficient resource allocation (e.g., sample collection)
 - Compliance and enforcement (e.g. unapproved, filth-insanitary conditions)



- Joint Inspection Planning Check list tool
- Food Laboratory (e.g., validated methods, Chain of Custody)
- National Food Safety Data Exchange- to share data electronically
- Developing data definitions for the common data for ORA internal and States data sharing
- Produce Safety Farm Inventory Initiative
